Based on Art. 30, 33 Fundamentals of the Legislation of the Russian Federation on culture, paragraph 3 of Art. 21 of the Law of the Krasnoyarsk Territory of June 28, 2007 No. 2-190 "On Culture", clause 3.29 of the Regulations on the Ministry of Culture of the Krasnoyarsk Territory, approved by Decree of the Government of the Krasnoyarsk Territory dated 08/07/2008 No. 32-p, approve the Regulations about the International Exhibition-Competition of Children's Art "Yenisei Mosaic" in accordance with the Appendix.

2. The order of the Ministry of Culture of the Krasnoyarsk Territory dated October 20, 2017 No. 298 is declared invalid.

3. The Department of Information and Public Relations of the Ministry of Culture of the Krasnoyarsk Territory (Ivanova E.N.) must publish this order on the official website of the Ministry of Culture of the Krasnoyarsk Territory on the Internet information and communication network (<http://krascult.krskstate.ru>) within 5 working days from the date of its adoption.

4. Entrust control over the implementation of the order to the First Deputy Minister of Culture of the Krasnoyarsk Territory Gelrud N.L.

**The regulations
of the International Exhibition-Competition of Children's Art
«Yenisei Mosaic»**

1. General regulations

1.1. This regulation regulates the order and criteria of organization and holding of the International Exhibition-Competition of Children's Art «Yenisei Mosaic» (hereinafter – Exhibition-Competition).

1.2. The founder of the Exhibition-Competition is the Ministry of Culture of the Krasnoyarsk territory.

1.3. The Organizer of the Exhibition-Competition is the Territorial State Autonomous Institution of Further Vocational Education «Krasnoyarsk territory Research and Training Center on Cultural Personnel» (hereinafter – the Organizer).

1.4. The partners of the Exhibition-Competition might be mass media, organizations, institutions, concerned parties.

1.5. The Exhibition-Competition is held once every two years from February until June. The precise dates and the subject of the Exhibition-Competition is determined by the Organizer in the year of the event.

1.6. The information about the Competition will be available in the Internet on the official web-site of the Organizer: <http://educentre.ru>.

2. Purpose and objectives of the Exhibition-Competition

2.1. The purpose of the Exhibition-Competition is to preserve and develop traditions of the academic artistic education, development of creative abilities of children and gifted youth.

2.2. The objectives of the Exhibition-Competition are:

to reveal gifted children in the field of fine arts;

to motivate young artists to develop their creative talents;

to draw young artists' attention to the culture and history of their country and the near and far abroad countries;

to expand creative relations between teachers of fine arts and decorative and applied arts from the Russian Federation and the near and far abroad countries;

to support mutual understanding and friendship between nations and representatives of various cultures.

3. Conditions and the procedure of the Exhibition-Competition

3.1. Participants of the Exhibition-Competition are the students of professional educational institutions, regular schools, institutions of further vocational education (hereinafter – institutions).

3.2. The Exhibition-Competition is held in two nominations:

fine art (all techniques: watercolor, gouache, ink, tempera, pencil, mixed techniques etc.);

decorative and applied arts (all kinds and techniques).

3.3. For each nomination of the Exhibition-Competition there are the following age categories:

3.4. The age of the Participant of the Exhibition-Competition will be determined on January 1 of the year of the event.

3.5. The Exhibition-Competition is held in two rounds:

I round – qualifying, artistic works are evaluated by the exhibition committee, held in the second ten days of April;

II Round – final, evaluation of artistic works by jury members, held in the second ten days of June.

3.6. Application for the Exhibition-Competition must be submitted by the Institute.

3.7. No more than 10 works of art from the Institute and no more than one work of art from each student can be accepted for the Exhibition-Competition.

3.8. Requirements for the works of art submitted to the Exhibition-Competition:

In the nomination «Fine Art» – sizes of the outer edge are no more than 50 x70 cm (works of art for the Exhibition-Competition are sent in the unfolded form);

In the nomination «Decorative and Applied Art» – sizes of the bottom are no more than 50 x 70 cm;

The reverse side of the artwork should have the label (font TimesNewRoman, size 18 bold), containing the following information in the strict order:

family name and first name of the author, age, name of the work, name of the Institute, name of the country, republic, region, district, city, village, family name, first name, patronymic of the teacher (complete). An e-copy (Word) of the label should be attached to the Application.

3.9. Substitution of the work, stated in the application, after it was received by the Organizer is not allowed. In case the work of art has been damaged while being transported, option of its replacement for participation in the Exhibition-Competition is considered by the Organizer individually.

3.10. The works submitted for the Exhibition-Competition, are not reviewed and not sent back.

3.11. The Organizer has the right to use artwork for printed materials, as well as for charitable purposes.

3.12. Submission of an application for participation implies acceptance of all the terms of this provision.

3.13. At the end of the Exhibition-Competition the winning works will be included in the catalogue that will be placed on the official web-site of the Organizer: www.educentre.ru

3.14. Award ceremony will take place on a ceremonial opening of the exhibition.

4. Organization of the Exhibition-Competition

4.1. For the preparation and conduct of the Exhibition-Competition the Organizer provides:

the placement of information about the exhibition-competition in the media and the Internet;

registration of applications for participation in the Exhibition-Competition from the Institutions;

appointment and approval of the Exhibition Committee;

appointment of the Jury;

elaboration of the regulations for the Exhibition Committee activity;

elaboration of the regulations for the Jury activity;

setting the theme of the Exhibition-Competition in the year of the event;

preparation the prize papers for the winners of the Exhibition-Competition;

preparation of the exhibition of the artworks – winners of the Exhibition-Competition;

preparation of the awarding ceremony for the winners of the Exhibition-Competition;

designing of the catalogue of the winning works and its placement on the official web-site of the Organizer: www.educentre.ru.

4.2. The Organizer is not liable for loss of the documents during the transfer.

4.3. Assessment of the works of art, applied for the participation in the Exhibition-Competition is held in two stages:

During the first round the Exhibition Committee selects submitted works of art for exhibiting.

The Exhibition Committee of the Exhibition-Competition is appointed and approved by the Organizer from among the leading specialists of institutions of further vocational education, professional educational institutions and educational establishments of higher education, implementing educational programmes in the field of fine arts and decorative and applied arts.

4.4. The Exhibition Committee of the Exhibition-Competition gives an assessment of the submitted works on the basis of the following criteria:

- wholeness of the artistic image, the unity of form and content;
- correspondence to the theme of the competition;
- understanding the patterns of space composition;
- color scheme, tonal relationships (color, transfer of state);
- artistic level and mastery of execution;
- imagery, spontaneity, freshness of feelings, independence of thinking.
- correlation between the level of the work and the author's age.

The result of the work of the Exhibition Committee is enshrined in the Protocol, which provides for the following statements: «the work of art is allowed to participate in the II round and exhibition», «the work of art is not allowed to participate in the in the II round and exhibition».

4.5. During the second stage works of art are assessed by the Jury of the Exhibition-Competition.

The Jury of the Exhibition-Competition is formed from among the leading specialists of professional educational organizations and educational organizations of higher education, implementing educational programs in the field of fine and decorative arts, Russia and abroad, cultural and artistic figures, leaders and members of professional creative unions, art critics.

The Jury of the Exhibition-Competition is approved by the order of the founder.

4.6. The Jury assesses presented works in each nomination and age category on a scale from one to ten and on the basis of the following criteria:

- originality of the creative concept, technical mastery;
- sense of harmony, artistic taste;
- sense of proportion, the originality of the image;
- sense of entirety and its correlation with attention to details;
- skillful combination of tradition and innovation.

Final assessment of every member of the Jury on every work is determined as an arithmetic mean value of their individual assessment on each of the criteria.

Final assessment of presented works is determined as an arithmetic mean value of assessment of all the members of the Jury.

The Jury defines the only Grand prize by simple majority voting in each nomination and age category from the works of art which got 10 points. Full voting status belongs to the Chairman of the Jury.

4.7. The Jury reserves the right:

not to award all the prizes;
to award one prize to several works of art;
not to award the Grand prize;
to establish special diplomas.

4.8. Decision of the Jury is enshrined in the Protocol, it is final and not subject to review.

4.9. The awarding of participants of the Exhibition-Competition provides for:

diplomas for the Grand prize winners in each nomination and age category;
diplomas for the participants, who took the first, second, third prize (laureates) and fourth prize (diplomates) in each nomination and age category;

letters of gratitude to the participants of the second stage of the exhibition-competition, who did not take prizes, for their successful participation in the exhibition-competition;

letters of gratitude to the participants of the first stage of the exhibition-competition, who did not qualify for the second stage, for participating in the exhibition-competition.

4.10. Diplomas and letters of gratitude are issued only in the form of electronic documents or electronic images of documents signed with an enhanced qualified electronic signature of the Organizer, by sending to the email address specified in the application for participation in the exhibition-competition.

4.11. Diplomas and letters of gratitude are issued within 30 working days after the end of the exhibition-competition.

5. Financial conditions of the Exhibition-Competition

5.1. The financing of the Exhibition-Competition is carried out by means of the budget of the Krasnoyarsk territory.

5.2. Travelling and accommodation expenses of the winners of the Exhibition-Competition to the awarding ceremony are to be covered by the contributing party or the participants.

5.3. The shipment of the works for the Exhibition-Competition is to be covered by the contributing party.

5.4. Registration fee for participation in the exhibition-competition not provided.

6. Filling out an application for participation in the exhibition-competition

6.1. Enrollment period is determined by the Organizer in the year of the Exhibition-Competition.

6.2. An application for participation in the exhibition-competition should include:

full name of the institution in which the participant receives education;

last name, first name, patronymic (if any) of the participant;
 date of birth of the participant;
 age of the participant (as of January 1 of the year);
 name of the nomination;
 age category;
 artwork name;
 the execution technique;
 last name, first name, patronymic (if any) of the parent (legal representative);
 telephone number of the parent (legal representative);
 E-mail of the parent (legal representative);
 last name, first name, patronymic (if available) of the teacher;
 teacher's telephone number;
 teacher's email.

6.3. The application is submitted by filling out the interactive form on the Organizer's website without the need for additional application in any other form.

6.4. Attached to the application:

parental consent (legal representatives) of the participant under the age of 18 to the processing of personal data in the form in accordance with Annex No. 1 to these Regulations;

parental consent (legal representatives) of the participant under the age of 18 to the processing of personal data authorized by the subject of personal data for distribution in the form in accordance with Annex No. 2 to these Regulations;

consent of the teacher to the processing of personal data in the form in accordance with Annex No. 3 to these Regulations;

consent of the teacher to the processing of personal data authorized by the subject of personal data for distribution in the form in accordance with Appendix No. 4 to these Regulations;

birth certificate or passport of the participant;

a document confirming registration in the individual (personalized) accounting system (for citizens of the Russian Federation);

a label in Word format according to clause 3.7. of this Regulation.

6.5. Documents specified in paragraphs 1-6 of clause 6.4. of these Regulations are sent as an electronic image of the document, created by using a color scanning mode with a resolution of 300 dpi.

The electronic image of the document must provide visual identity to its paper original on a scale of 1:1.

An electronic image of a paper document is created in PDF format.

If a paper document is compiled on each page of one sheet or consists of two or more sheets, the electronic image of such a paper document is generated in the form of one multi-page electronic file. The file name must allow identification of the electronic image of the document.

6.6. Applications received after the deadline determined by the Organizer and that do not meet the established requirements are not registered by the Organizer.

6.7. Artistic works for participation in the exhibition-competition are sent to the Organizer only after receiving confirmation of registration of the application.

6.8. Artwork for participation in the exhibition-competition is sent by mail to the address: 663090, Krasnoyarsk Territory, Divnogorsk, st. Chkalova, 43, Territorial Krasnoyarsk Scientific and Training Center for Cultural Personnel.
